HOW DOES AN ONLINE FEIS WORK?

Register and pay online at www.quickfeis.com for the Inaugural Feis up to 11:59pm on 21st March 2021.

As soon as you pay for your registration you will be given your dancer number on your Quickfeis account. PLEASE DOWNLOAD AND PRINT OFF THIS NUMBER FOR LATER USE

Practice and film your video

- Use your smartphone for the video.
- You must wear your dancer number throughout the recording.
- The video MUST be recorded in LANDSCAPE MODE.
- Dancer must be alone in the video.
- Music must be clear.
- A separate video for each dance is required.
- Editing of videos is **STRICTLY PROHIBITED**.
- Additional Guidelines below.

From 3rd April, go to VIDEO FEIS, log in with your QuickFeis account – upload all your videos.

- Upload your video no sooner than 3rd April 2021.
- All videos must be uploaded by 11.59pm 4th April 2021.

All videos will be securely viewed by Adjudicators on the 17th & 18th April. They will score and provide critiques for all performances. Quickfeis will thereafter tabulate all results which will be announced by 25th April 2021.

All competitors will receive:

- A competitor certificate of participation.
- A commemorative sash or pennant of participation.
- Their individual results.
- Specific comments and critique from adjudicators in every dance.

In addition

- Competitors placing 1st, 2nd & 3rd in solo competitions will receive certificates of their achievements
- Competitors placing 1st, 2nd or 3rd in Preliminary or Open Championships will receive special sashes/pennants recognizing their achievements.

ENTRY FEES

Full payment is required at the time of registration. Your registration is not complete until full payment is received. Any unpaid registrations will be automatically deleted at the end of the online registration period.

Sterling (£) funds only will be accepted via credit or debit card. There are no facilities to accept payment by cash or cheque.

Fees for solo competitions are per dancer per dance. Championship fees cover all three rounds per dancer.

Online registration will close at 11:59pm on 21st March 2021. No additional registrations or changes will be accepted after this deadline.

ABSOLUTELY NO REFUNDS will be given after 11:59pm on 21st March 2021 for any reason.

FEIS FEES

Grades (Beginner, Primary, Intermediate & Open (U6 & U7 Only) £4 per dance

Preliminary & Open Championships £25

Family Maximum £65

(Please note that even if you qualify for Family Maximum, full payment must be made during registration. Refunds in respect of the family maximum will be reimbursed directly from SRC once registrations are closed)

COSTUMES

You are encouraged to wear your dance costume – however, you are also permitted to wear an all-black outfit.

You must wear proper Irish dance shoes.

You must always wear your dancer number during your video – failing to wear your number will disqualify your video.

FEIS RULES

- 1. A PARENT/GUARDIAN or dancer over the age of 18 must sign an online waiver as part of their registration.
- 2. A PARENT/GUARDIAN or teacher must be present during filming of the submitted video(s) if the dancer is under 18. **Safety must be a priority**.
- 3. It is the sole responsibility of the parent/guardian or in the case of dancers over 18, the dancer themselves, to ensure the performance space is safe, uncluttered, non-slip and suitable to dance in.
- 4. Only dancers of teachers registered with An Coimisiún le Rincí Gaelacha can enter the Online Feis and only after they have received the permission from their teacher(s) to do so.
- 5. This Online Feis committee reserves the right to refuse any video for any technical reason or rule violation.
- 6. All videos will be downloaded, stored, and securely delivered to the adjudicators via VIDEOFEIS.
- 7. Videos will be permanently deleted 7 days after the competition results have been announced.
- 8. All videos are by default marked as PRIVATE and cannot be used for any purpose other than for adjudication purposes.

MUSIC INSTRUCTIONS

By participating in this online feis you must use the music provided specially on the BEAT MUSIC APP.

A specific folder on the Beat Music App will be available to dancers from 1st April 2021 and will remain available until 11:59pm on Sunday, 4th April 2021.

Music cannot be dubbed over the video. The video must capture both the dancer and music at the same time.

Music must be distinct enough for the adjudicator to hear clearly so as to allow proper appraisal of timing.

No other sound except the music and dancer's shoes should be heard on the video.

Talking, singing or coaching on the video is strictly prohibited.

COSTUMES

All rules as per SRC Costume policies

- Dancers may wear Solo or Team Costumes, Blackout Outfits or white or black short sleeve t-shirt, with black bottoms (trousers, shorts, or skirts of an appropriate fit and length)
- Dancers in Beginner and Primary competitions up to and including Under 12, may only wear class costumes, skirt and blouse or appropriate civilian clothing. Low cut tops or short tight skirts are not permitted. Failure to comply with this rule may lead to disqualification from the competition.
- Costume Length: Length of costumes must adhere to principles of modesty and enable dancers to safely execute their movements and steps. Adjudicators who determine a costume to be too short may make comment accordingly. When wearing body suits with skirts (commonly known as black-out attire) black tights (of a denier no less than 70) must be worn from the age of 14 and above.
- No logos or school names on blackout outfits please, no team apparel (sportswear or warmup outfits)
- Correct Soft and Hard Shoes and proper socks or tights must be worn at all times. No carriage aids are allowed.
- Natural hair or wigs allowed; hair must be off dancer's face.

Make-up Rules (4.5 in CLRG Rule Book)

- Make-up will not be permitted for any dancer in the **first two grades** (Beginner and Primary) up to and including the Under 12 age group worldwide.
- Make-up (including false eyelashes) is not permitted for dancers, in either solo or team competitions, up to and including the Under 10 age group.

(POINT OF CLARIFICATION) For the purposes of this rule the term "make up" includes tinted moisturiser and any artificial tanning products. An Coimisiún hopes that teachers and parents will interpret and apply this rule in the spirit in which it is intended.

A dancer winning **1st or 2nd** in the BEGINNER grade, when there are 6 or more competitors, must dance that particular dancein PRIMARY grade (or above) for at least 12 months.

PRELIMINARY CHAMPIONSHIP (3 rounds)

- A minimum number of three Adjudicators will officiate the Championship.
- The first age group for a Preliminary Championship is Under 10.
- If competing in a Preliminary Championship, a dancer cannot compete in an Open Championship.
- Three rounds are required, namely, Heavy Jig or Hornpipe, Reel or Slip Jig, and any Set Dance.
- Where a competitor wins two Preliminary Championships, they must dance in Open Championship for a period of 12 months thereafter.
- For grading purposes, two wins will be taken as being in any two-year rolling period. Where a dancer does not win a second Preliminary within two years of winning their first Preliminary Championship, then the first win will be deemed as having expired and the dancer starts afresh.
- Where there are less than 6 in a Preliminary Championship that win will not normally be considered for grading purposes. However, where a dancer wins three Preliminary Championships regardless of the number of competitors in each competition, that dancer must dance in Open Championship for a period of 12 months thereafter.
- Dances performed in a Preliminary Championships do not count for grading in solo competitions.
- Competitors that qualify for and compete in Oireachtas Rince na Cruinne in the previous 12 months cannot compete in a Preliminary Championship except where the dancer auto qualified at their Regional or National Oireachtas due to lack of numbers.
- Dancers placing 1st-3rd in an Open Championship with up to 20 competitors or 1st-5th in an Open Championship with more than 20 Competitors cannot compete in a Preliminary Championship for a period of 12 month.

Preliminary Championship dancers will submit 3 videos:

- Round 1 8 Bar Intro + 32 Bars of dancing of Heavy Jig or Hornpipe
- Round 2 8 Bar Intro + 32 Bars of dancing of Reel or Slip Jig
- Round 3 Intro and Traditional or Open Set Dance of Choice

- Round 3 Intro and Traditional or Open Set Dance of Choice

PLEASE ENSURE THAT THE CORRECT VIDEO IS SUBMITTED FOR THE CORRECT ROUND

VIDEO RULES

- Dancer will only be allowed to submit videos for competitions they have entered and paid for.
 - o Grades will submit one video per dance competition.
 - o Prelim champs will submit three videos.
 - o Open champ will submit three videos.
- Upon payment, all dancers are assigned a dancer number that they can either print or copy on a piece of paper. This DANCER CARD must be worn by the dancer during the entirety of each of their videos for the feis. Any dancer not wearing their assigned DANCER CARD will automatically be disqualified from the feis.
- Dancers are required to create an original new "FEIS VIDEO" of their dance(s) i.e. a video that has been
 recorded AFTER they registered for the competition and is specifically for this feis and no other event or
 social media.
- Feis videos are not allowed on social media or shared with anyone before or during the feis. Any dancer found to have shared their video during the feis will be disqualified from the feis.
- The dancer registered for a competition must be the dancer on the video (no substitutions allowed).
- ONLY THE DANCER IS ALLOWED IN THE VIDEO Teachers/parents/others may NOT be visible.


It is HIGHLY recommended that all dance videos be only recorded using a standard smart phone.

- Use the standard camera application for your device when recording.
- Use the standard settings for recording the video. Please avoid any embellishment.
- The quality (resolution) and size of the video is limited to what is produced by a smartphone.

If you elect to not use your smart phone to record your video, you **must** follow these guidelines:

- Video should be recorded at 720p or 1080p, 30fps or 60fps. Higher resolution video may not be submitted.
- The submitted video must be one of the standard video formats that can be played in a web browser. This includes, but is not limited to: MPEG-4 (H264), MPEG-5 (H265), MOV
- webm video format will not be accepted.
- Special lenses (like a fish-eye lens, or wide-angle lens) are not permitted to be used when recording.

Video must be in LANDSCAPE mode and not portrait mode. (See image below)





Videography should be from a single static point (pretend you are the centre judge sitting at a table)

- Camera should be about 4 feet (125 cm) from the ground.
- Camera should be in front centre of the dance floor (avoid being on the side)

Videographer can pan side to side to keep the dancer full body within the video frame.

Video for each dance must be one continuous front **FULL BODY SHOT** – **Head and Feet must be visible at all times throughout the video.**

NO EDITING of the video is allowed.

- Any spliced videos will automatically be disqualified.
- Videos are not to include any embellishment or photoshop type of touch ups.
- The video should start as soon as the introductory 8 bars start and finish no more than two seconds after dancing has ended. *This is a request to make adjudication more efficient*.

The feis nor anyone working with the feis will not held responsible for any injury, or property damage in the making and/or submission of the video.

The feis reserves the right to refuse any video for any technical or rules reason.

Incorrectly uploaded videos - for example a Hornpipe is uploaded instead of a Slip Jig - will be given a score of **ZERO**. An explanation along with a deemed score will be included in comments.

COMPETITION RULES

- All the rules for the feis are listed in the feis syllabus. If a rule is not specifically listed, the feis rule falls back to the general feis rules of the Scottish Regional Council.
- You must register for each competition you wish to submit a video for. You will not be permitted to add more dances after the registration deadline.

The Scottish Regional Council reserves the right to

- Cancel any competition with no entries.
- Amalgamate competitions together if there are not sufficient numbers in single competitions.
- Splitting any age group if there are too many competitors in a competition.

Dancers must submit their video within the time frame listed in this syllabus.

No late video will be accepted after the deadline has passed.

Dancers will advance in Level as a result of this First Online Feis in accordance with the Scottish Regional Council rules.

DANCING RULES

- DANCERS MUST WEAR THEIR DANCER NUMBER THROUGHOUT THE VIDEO RECORDING
- ONLY THE DANCER IS ALLOWED IN THE VIDEO Teachers/parents/others must NOT be visible.
- Music and dance must match the competition registered for. (For example, a HORNPIPE competition must have HORNPIPE music and dance HORNPIPE steps).
- At the conclusion of the dance, the dancer should simply bow, and the video should end. Please refrain from walking before bowing.
- Coaching is **STRICTLY PROHIBITED** during the performance.
- Any visible or audible coaching will disqualify the video.
 - o The only exceptions will be for beginner dancers who may need to be counted in.
 - When the beginner dancer has started their performance, no further counting or coaching is permitted.

32 BAR RULES FOR ONLINE FEIS

- 32 Bars of dancing only, except for Traditional and Open Set Dances, where the full dance is required.
- 32 Bars can consist of ANY of the following:
 - o Lead Around 16 & First Step 16
 - o First Step 16 & Second Step 16
 - Lead Around 8, Side Step 8 First Step 16
- Reel and Slip Jig. Lead Arounds can be Right Foot Twice
- Jig and Hornpipe Lead Arounds must be performed on Right and Left Foot
- When a dancer is required to perform a step on the right foot and the left foot, all movements in the first 8 bars of the footwork must be replicated on the opposite foot in the second 8 bars.

DANCE AREA

- Dance surface should be safe and suitable to dance on. Dancers should avoid dancing on concrete or carpets.
- Area should be well lit so that the dancer is clearly visible throughout the video.
- Maximum dance area is 6 ft by 12 ft.
- There is no minimum dance area.
- Background should be neutral and no form of school or personal identity visible.
- Area as light (white) as feasible to create contrast with the dancer. This is a recommendation and not a requirement.

ADJUDICATION

Adjudicators are subject to all rules and regulations of CLRG and have been selected by random draw.

ADCRGs have completed an agreement to protect intellectual property and privacy and will not be allowed to record or retain any video footage or choreography.

Selected adjudicators will not be considered for selection to adjudicate the Scottish Regional Council Regional Oireachtas in 2021.

Each Grade Competition will be adjudicated by 1 judge from the selected panel.

Each Preliminary and Open Championship will be adjudicated by 3 judges from the selected panel.

If additional adjudicators are required due to the number of entries, the next adjudicator per the random draw will join the panel.

Assignment of competitions to each Adjudicator will be done randomly by Quickfeis. No member of the Scottish Regional Council will participate in this process.

All adjudicators will be encouraged to give copious comments along with their scores.

Incorrectly uploaded videos (for example a Hornpipe is uploaded instead of a Slip Jig) will be given a score of **ZERO.** An explanation along with the deemed score will be included in the comments.

Adjudicators will be asked to monitor the tempo of the music – any tempo that is not appropriate or any music used that has not been downloaded from the Beat Music App will disqualify the video.

Adjudicators will be permitted to disqualify any video that they deem is not in compliance with video requirements or is not in the spirit of this competition.

In all matters relating to judging, the decision of the adjudicator is final.

PRIVACY

- All submitted videos automatically become the property of VideoFeis.
- All submitted videos are by default marked as PRIVATE unless additional permissions are given upon uploading.
- All submitted videos may only be viewed by:
 - Feis Adjudicator(s)
 - Feis Organiser(s)
 - School dance teacher(s) (of that dancer)
 - VideoFeis staff
- QuickFeis and VideoFeis will share all data with each other and the feis organiser.
- QuickFeis and Video Feis will not share nor sell any data or videos with any third/outside party.

PERMISSIONS

Before uploading any videos on the VideoFeis site, participants will be requested to carefully read and grant the following permissions:

BASIC Permission is REQUIRED before uploading any video.

- This permission grants VideoFeis permission to show all videos to VideoFeis staff, feis organisers, dancer's dance teacher(s) and feis adjudicators only.
- Videos with only BASIC permission are considered PRIVATE and will be deleted directly after the completion of the Feis and results announced.
- By registering and agreeing to the basic permissions required, participants agree that their registration allows competition information and data to be shared between QuickFeis and VideoFeis and the Feis organiser.

RELEASE OF LIABILITY

By registering and paying for the feis, dancers and their parents/guardians agree to release the dance school, teachers, any workers associated with the region, QuickFeis and VideoFeis of any liability for any injury arising for during the completion of any requirements for this competition.

The feis nor anyone working with the feis will not be held responsible for any personal injury, or property damage in the making and / or submission of the video.

INDEMNIFICATION AND REL EASE OF LIABILITY; By registering and paying for this feis, you indemnify and hold harmless the SRC, CLRG, QuickFeis and VideoFeis and its staff or assigns from liability or injury related to their participation in this competition. Registrants must be in good physical health and not under medical advice that would prevent them from participating in physical activity. Parents, teachers, or supervisors are responsible for ensuring the safety and wellbeing of dancers at all times before, during and after filming their submissions. Parents (or dancers over 18) must indicate that they understand, accept, and agree to these conditions at the time of registration.

SCOTTISH REGIONAL COUNCIL RULES

Objections against any breach of any rules pertaining to the Feis must be made in writing, and signed, to the Vice-Chairman of SRC and accompanied by a fee of £25.00, which will be refunded if the objection is upheld.

If parents have any constructive comments to make about any aspect of Feiseanna, these would be welcomed by the council and should be put in writing. It should be noted that anonymous correspondence cannot be dealt with.

Lodgement of entries implies that you acknowledge and accept all the Rules of An Coimisiún Le Rincí Gaelacha and the Scottish Regional Council plus the additional rules relating to the Feis.

- 1. Ages to be taken from 1st January 2021.
- 2. Should a query arise relating to the age of a dancer, the pupil's teacher must provide proof of age original birth certificate or passport must be produced.
- 3. Competitors must dance in their own age group for solo competitions except where there is no competition in their age group for that particular dance. Dancers cannot compete in a younger age group.
- 4. Competitors may only dance each dance once only in grade competitions.
- 5. A Beginner is a dancer who has not gained a 1st, 2nd or 3rd place in a Beginner Grade competition or any medal in a higher grade for that particular dance.
- 6. The basic step rule will apply to all Beginner competitions.
- 7. The Primary Grade is for dancers who have not won a 1st or 2nd place for that particular dance in a Primary Grade competition or any medal in a higher grade for that particular dance.
- 8. The Intermediate Grade is for dancers who have not won a 1st place for that particular dance in an

Intermediate Grade competition or any medal in a higher grade for that particular dance.

- 9. Intermediate competitors can dance their grade dances and either the Preliminary or Open Championship.
- 10. An Coimisiún has ruled that from 1st January of each year, that no block, en pointe, stationary or moving be allowed to be performed for all ages up to and including the under 12 age group Worldwide. The Under 12 Age Group will be allowed to Toe Walk from 1st September.*

For clarification purposes, this means that if the full weight is put on the foot, that is "en pointe" and is not allowed in any movement (added 27.01.2019)
